

He has served on the 2014, 2015, 2017 and 2018 Centers for Medicaid and Medicare Services'(CMS) Hospital-Acquired Condition (HAC) Reduction Program Technical Expert Panel, along with the AHRQ Standing Working Group for Quality Indicators for 2016 to 2017. Currently, he is serving on the Mathmatica Hospital Harm Technical Expert Panel which develops patient harm measures for CMS and has served as a member of the National Quality Forum's Consensus Standards Approval Committee.
